IN RE: BATTERERS' INTERVENTION PROGRAMS FOR THE NINETEENTH JUDICIAL
CIRCUIT

Administrative Order 2015-01 was entered to address certification and monitoring of batterers' intervention programs ("BIPs") providing services to the courts of the Nineteenth Judicial Circuit. It has been determined that the selection of a private monitoring entity to monitor BIPs providing services to the courts of this Circuit should occur after completion of a public procurement process.


NOW, THEREFORE, pursuant to the authority conferred by Florida Rule of Judicial Administration 2.215, it is **ORDERED** as follows:

All certified BIPs currently on the list maintained by the 19th Judicial Circuit Court Administration, pursuant to Administrative Order 2015 – 01, shall continue to meet all requirements of 741.325, Florida Statutes and any other related statute;

Authorization/designation of Abuse Intervention Monitoring, Inc. to conduct the certification and monitoring of BIPs providing services to the 19th Judicial Circuit is suspended pending completion of a public procurement process and further order of this court; and

All other provisions of Administrative Order 2015 – 01, not inconsistent with this order, remain in full force and effect.
