ABOUT US: The Indian River County Lawyers Auxiliary celebrates 12 years of service this year and is the only lawyers auxiliary in the state of Florida! Our mission is to promote law and justice through education and service and to support our local Bar Association.

Programs sponsored by the lawyers auxiliary include the Dependency Court Project which provides toys and books to the courts for children involved in dependency proceedings. The 2nd & 3rd Grade Literacy Challenge serves a Title I school and over 60 children per month. This program gives each child one new book a month to encourage reading and help build home libraries.

The lawyers auxiliary also works to place attorneys and judges in classrooms during law week. Although the law week theme changes each year, the basis is always the rule of law while emphasizing open and accessible courts are the cornerstone of a free society.

Our newest program is "A Constitution in Every Pocket," geared toward 7th-grade Civics students who are each provided with a U.S. Constitution at the start of the school year.

Lastly, the auxiliary partners with the Education Foundation in its "Tools to Learn" school supply project, making school supplies available to children in public and independent schools in Indian River County through their teachers.
